Giuliani is now fighting multiple lawsuits and disciplinary actions related to his efforts to challenge the 2020 election results. He faces billion-dollar defamation suits, disbarment proceedings, and criminal charges in Georgia.

Supporters in this file are highly motivated by themes of legal injustice, election integrity, and defending Trump-aligned figures. They are proven mail-responsive donors with strong affinity for America First messaging.
